Our First Time

There are many accounts of couples debating the merits of naturism before tentatively taking that first step and shyly dipping a bare toe into the water. Maybe he or she swore they would never go naked in front of strangers, only to find that it was relaxing and fun. After a few moments they no longer felt self-conscious about being naked, and the strangers never cared in the first place. Sometimes it takes a while to gather the courage for that first visit. This was not the case with Monica and me. There was not much discussion, and certainly no debate. One day I asked Monica if she would like to visit a nudist camp, she said “sure,” and away we went.

Neither Monica nor I can recall a period when we were uncomfortable with nudity. The recent “Bare Facts” essay “The Shower Room” by Ernie C. prompted a discussion about Monica’s son who managed to complete high school without undressing in the locker room in front of others. He is shy even around other males his age. Perhaps there is a generational divide on the issue. Monica is 47, and I am 56, and during our high school years we each played sports and used locker rooms. There was never a time when either of us felt unease, nor were we aware of any peers’ discomfort with nudity. Monica tells amusing stories of liking to play naked as a little girl and her mother dressing her for kindergarten in clothes that buttoned down the back so she couldn’t take them off. I was raised with two brothers, and we shared baths and lived at home in various states of undress with no concern for modesty. However, I should add that both Monica’s family and my own think we are pretty much nuts, and none of them will consider trying nudism.

A few years ago I had the opportunity to visit Romania in the Peace Corps, and I witnessed the European attitude toward nudity. German cable TV channels offered news reports from nudist camps extolling the virtues of a clothing-free lifestyle. Participants were interviewed on the screen, and viewers had the opportunity of “visiting” a camp from the privacy of their homes. These reports were not pornographic or titillating in nature. Nudity was seen as it is – natural and normal.

That attitude extended to Romania. Those in my Peace Corps group, about fifty of us, shared co-ed bathroom facilities at our initial training school with local staff and each other with no loss of modesty or decorum. Nude beaches exist in eastern Romania along the Black Sea, although I lived and worked in the western part of the country and never managed to visit one. When I returned to the States, I decided to explore nudism as a lifestyle. At the time, Monica and I were living in her country home in Chase County near the Cottonwood River. We had discovered remote areas along the river where we could hike in the buff and especially enjoyed long walks together at dusk. However, a move to Emporia ended those nude treks, so I “Googled” nudist camps and was amazed to find they existed right here in Kansas.

Breast-Feeding In The News

WEST Branch, Iowa. In 2000 the Iowa legislature passed a law that allows breast-feeding in public places. The intention was to promote the practice, but with discretion, according to two former state senators.

“We did not intend that it should be flaunted, that people should just whip out a breast, but that they should be discrete and have some method of covering up, and if this could not be done that it needed to be done in a restroom,” said Patricia Harper, a former Democratic senator.

A spokesman from the Iowa Attorney General's Office stated that the law is similar to policy in 30 states. “We didn't want women to feel that they had to go to extremes to go to a private place or that they should have to run off... but the act also shouldn't infringe on other people's rights.” The law does not describe the manner in which a woman should breast-feed, but advises mothers to be considerate of the establishment and vice versa.

On July 3, Iowa City resident Amy Schoon claimed she was “discreetly” breast-feeding her son at The Hoover House when a waitress and, later, co-owner Janet Nelson told her to continue in the bathroom or leave.

Restaurant co-owner Carl Nelson said Schoon was given options: to cover up, continue in the bathroom or leave. He said the family restaurant does not prohibit breast-feeding, but he prefers mothers cover up with a blanket.

The Schoon incident upset breast-feeding advocates who were incited even more after learning The Hoover House restaurant twice has held wet T-shirt contests this summer.

About 50 breast-feeding women gathered to protest the treatment of a woman breast-feeding. These mothers held a “nurse-in,” filling the Downtown Family Restaurant which is across the street from The Hoover House.

The women also breast-fed their babies while standing in front of the offending restaurant. Michelle Brown stated, “I need to feed my baby when she's hungry. It's not shameful. It's natural.”

One Hoover House waitress, Nicole Cumbo, 15, is quoted as saying “If I worked tonight, I would refuse service to anyone who had anything to do with this. Nobody wants to eat and see somebody breast-feeding a baby.”

What a disturbing story. No one was concerned about the wet T-shirt contests where female breasts were exploited. Apparently, the owners and waitresses see this manner of displaying breasts as the proper role, while witnessing babies receiving nourishment as so repulsive and disgusting viewers would be unable to continue eating. This story demonstrates the power of societal myth to fetishize the breast and turn it's natural function into something dirty, needing a state law to authorize its natural use in public.

In my preschool youth of the 1940's there was still the remnant of sanity about babies and their mother's breasts that predated the Second World War and universal baby formula. I recall that on more than one Sunday morning in church various mothers breast fed hungry infants while remaining in the worship.

Notable among these mothers was the pastor's wife, seated on the front pew. This was a woman that breast-fed with conviction. No demure draping with a bedspread's worth of blanket for her. When that baby cried, she unbuttoned her blouse, reached in and pulled out a breast to suckle the child. No one was aghast, not even my very straight laced parents. I never witnessed this degree of normal breast-feeding of infants again until I spent time in East Africa.

Naturally, no one wants to shock and offend, nor did the mother in the story. I admire the grit of the 50 protesting women and the creativity of having a nurse-in. What a great way to use absurdity to illustrate absurdity of not just this particular restaurant, but of our culture in general regarding the breast. Would that there be a rash of nurse-ins across the country!

Particularly interesting are testimonials and photo's from women testing the legal right in some jurisdictions for women to be topfree. Believe it or not, courts in some states have ruled in favor of women's topfreedom. Find out where. However, having the legal right and exercising it is daunting for most, but dedicated advocates demonstrate that it can be done.

It is not easy to always understand the outcome of our choices many times. We, as naturists, would want the right to be naked more than we are allowed by our society now. We are thrilled when such opportunities present themselves to us, such as the recent e-mail to the police from one of the city attorneys in Topeka, which on the face of it suggests that officers responding to complaints of nudity that do not appear lewd and lascivious in nature, should ask the person or persons involved to cover up and not to write them a citation. One for us! Or not?

Most textile people I know have an inseparable connection between nudity and sexual conduct. When they see anyone without clothes clinging to their bodies they automatically judge the action as sexual in nature. After all, the only times they themselves are naked, is when they shower – alone, or are having sex! So when our neighbors see us doing yard work, taking out the trash, or just sitting on the porch in our natural states they will call the cops because we are obviously lurking and looking for someone to have sex with! What are the chances that the officer(s) who come will understand what the nudity ordinance really is?

And so we get to the unintended part of the law, which I think we all understand.

Lake Edun is one place where we all can go and enjoy the great outdoors as it was meant to be enjoyed! Just look at the smiles of the Eduners you meet on the trails and at the beach. We are in our element! And yet we are always mindful of those who live nearby who think we are doing something wrong and disgusting! We have invited them, but they will not come. Are they fearful? Missouri Madness

The Elk River in McDonald County in extreme Southwest Missouri was the scene of a clash between a group of canoeist and a party on a private beach. A group of about 20 canoeists rounded a curve on the river near the beach. Several of the women in the group were topless. Diane Smith, one of the group of women and children on the shore, asked the women to put their shirts back on because of the presence of the children.

Smith alleges the canoeists started cursing at her and Pepper Evenson, wife of the McDonald County sheriff. Smith then pulled out her cell phone and started to call 911.

Smith reports that, "They got really upset, and one guy went crazy. "He grabbed the phone and threw it in the river and hit me twice and threw me down on the ground. Our children were nearby, and they were screaming and very upset. One of the women jumped on Pepper's back when she pulled out her phone, but she was able to hold on to her phone and call for help."

Michael Royal, 26 of Olathe, Kansas was charged with felony second-degree robbery for taking the phone and four misdemeanors for assault, endangering the welfare of a child, and one count of trespassing.

Sheriff Evanson and Prosecutor Steve Geeding and the commissioners had been discussing an ordinance banning nudity on the river for several weeks. There have been several other incidents of men and women flashing people on the river and beaches. "This fight was just the final straw."

The ordinance defines the crime as a class A misdemeanor, punishable with a fine of up to \$1,000. The ordinance was passed unanimously by the commissioners and takes effect immediately.

Commissioners quickly followed up with another ordinance banning nudity on land as well. Nudity is defined as showing either male or female genitals or the female breast with less than opaque covering on any part of the nipple.

State nudity law only specifies public exposure of male and female genitals as illegal, but does not cover public exposure of female breasts. As a result, only sheriff's deputies can make an arrest when topless women are encountered in McDonald County.

[It's amazing the harm a few discourteous, and possibly intoxicated people can do. This would have been a non story if the canoeists had not taken offense and the women had agreeably put on a t-shirt for the few minutes it would have taken to move out of view. -Ed.]
