## Sun Anyone?

It seems the world of science is catching up with the late 19<sup>th</sup>, early 20<sup>th</sup> century in recognizing the benefits of heliotherapy. Most of you will know this by its modern name – sunbathing. Yeah. Good old solar radiation, aka natural sunlight!

Prior to WWI there were a number of medical doctors in England and on the continent that experimented with the healing properties of natural sunlight. Remember, back then there were no antibiotics. Diseases caused by bacteria claimed a huge number of lives. Standard medical treatments made little difference. A few bold experimenters became convinced that a combination of sunlight, clean air, and a healthy diet – usually vegetarian, offered hope for cures eluding the medical establishment.

These pioneers established clinics in the mountains of Switzerland where the sunlight was even more intense and began treating the ill. Their results were remarkable. Recovery rates for diseases such as tuberculosis significantly exceeded those of the standard methods.

Heliotherapy was not exceeded in cure rate until the advent of antibiotics during WWII. Unfortunately, the misuse of antibiotics has created strains of “superbugs” that only respond to the most powerful antibiotics.

But, back to our real topic. The latest medical advice is that we indeed need a certain amount of un sun-screened exposure to natural sunlight. The reason? It is reported that 75% of Americans aren't getting enough vitamin D, and the consequences can be severe.

Vitamin D deficiency has been linked to everything from cancer to diabetes, osteoporosis, and heart disease. Further, vitamin D aids in calcium absorption, keeps us agile as we age, and may fend off colds. Possibly it could make us better athletes by improving reaction time and building muscles.

Consider this. You can get all the vitamin C you need daily with one 8 ounce serving of orange juice. However, to get sufficient vitamin D you would need to drink ten tall glasses of milk or eat seven pounds of wild salmon every day.

The body uses ultraviolet light to synthesize vitamin D naturally. The problem is, high SPF sun block lotions prevent the ultraviolet rays needed for its production. The UV triggers a form of cholesterol in the skin that is converted into vitamin D in our kidneys.

Different skin types and diets make everyone's sun needs unique. Generally short sun exposure of more skin is a lot safer than longer exposure of just your face and hands. Both the American and Canadian cancer society have concluded that supplementation and small amounts of sun exposure are the preferred methods of obtaining vitamin D.

So how much sun exposure is now being recommended by doctors? They suggest that 3 to 10 minutes of sun exposure with 40% of your skin bared, twice a week during the summer is enough to get almost a year's worth of D. After this, use sunscreen.

The information about vitamin D comes from the June/July issue of Adventure Magazine. [Ed]

I realize that these people are onto something, and that it takes maturity to be able to hold it down like this when you're all nude. At the end of the evening, after retreating to the guest bedroom to put my clothes back on, I say my

goodbyes. I am invited back and told to bring friends. I take their invitation seriously, but am not sure if I want to become a lifetime member just yet. I hug the women and men and promise to come back. And on the way out, I don't even glance at the penises.

## The Sexting Controversy

Probably everyone is aware of the so called "sexting" controversy. If not, in short it has to do with young people sending nude pictures of themselves by phone to friends, and at times find them forwarded to the internet.

Authorities have had some extreme reactions such as wanting to charge the teens involved for child porn. Naturists on the other hand have argued the relevance of the issue for naturism.

The following is an online post discussion of the subject. [Ed.]

"I disagree on relevance. To the extent that naturism is about body acceptance, incidents like this are illustrations of a basic naturist issue. To be perfectly obvious on this point, when the mere sighting of a bare breast is a non-event, the attraction will be gone, this wouldn't even come up as babes and strippers, and ... naturists would be better off generally. The last really shouldn't require any more explication."

Actually I'm finding this a bit obscure. I think you're saying that if the naked body became familiar, there would be no place left for strip performances (or "sexting" either). If I've got that right, then I agree, but we're far from achieving that nirvana. Instead, at present our textile-compulsive society has made nudity such a fraught issue that it can never be treated casually. What most people assume is that nudity has to be a sexual event, and that's what was being presented in the Vassalboro coffee shop, in the hope of attracting more business. That's exactly what doesn't happen at a nude beach! As with the equally ridiculous sexting topic, the interest we should be taking in these things is the way it lets us point out how compulsive clothes-wearing makes the body into a fetish object. What I mean by "fetish object" is something that's automatically sexual, even if it's not that way by any reasonable logic.

We could and should be saying that nudity can be a completely ordinary occurrence, not involving any expectation of sexual arousal, and we'd all be better off if it were treated that way. Instead, I think that far too often, we see news reports of pathetic uses of nudity as eroticism, (topless waitresses, kids sending each other "naughty" pictures) and the social reaction against it, (prosecution of the sexting kids; the destruction of the topless coffee shop). What we should be doing is just pointing out how all this is based on a misguided view of nudity. Unfortunately, we're tempted to defend the things we should oppose, because we see it as "nudity."

In the sense that there's skin visible, it's "nudity," but it's a clothing-compulsive style of nudity. We need to make it clear that we've got a totally different approach. If we don't, we're throwing away an opportunity.

## It's A Crazy World

For a small town in Maine the scandal of a novelty coffee shop featuring bare chested male and female wait staff has taken an unexpected turn. The town considers the shop a "sexually oriented business" which it intends to further regulate.

What was a fairly tame sales gimmick – the topfree wait staff, now has the owner making plans to raise the bar higher – a lot higher. He's now thinking of expanding into being a strip club. If the folks are upset about a topfree coffee shop, what will they think of a strip club in their midst? It's the law of unintended consequences at work.

The point isn't that either of these business options is naturist in philosophy or orientation. They aren't. The observation to be made is that the phobia and resulting hysteria about female breast exposure creates the climate necessary for these businesses to succeed.

The message from naturism is that the body isn't taboo. It is just the body which is good in all its parts and functions. Should society accept this principle, the prurient curiosity "sexually oriented" businesses thrive on would be greatly diminished and the exploitation of female breasts or nudity for profit would decline. But, in keeping with conventional wisdom – if it doesn't work, just keep doing it, only harder. Oh! One last question. When did breasts become genitals?? [Ed.]

The owner of the controversial coffee shop which features topless female and male waitresses and waiters, which opened last February, recently disputed a report that one of his waitresses had been outside of the shop without a top on.

The complaint of a bare-breasted waitress outside the shop was investigated on Saturday by a state trooper. The shop owner said the waitress was outside on the shop's deck, but she had her breasts covered. While not wearing a shirt, she was covering her chest with her hands and arms as she propped open the front door.

The waitress in question stated, "I wasn't exposing my breasts to the public; I was totally covered. It was pretty much a big misunderstanding."

The investigating state trooper said he didn't charge anyone and would file a report with the district attorney's office for review.

However, the owner did promise at the (Planning Board) meeting that it wouldn't happen again. Screening will be installed on the building and waitresses would stay inside.

Maine state law doesn't appear to outright prohibit partial or full nudity in public. But there are provisions against "public indecency," which the law says includes sexual acts or exposing ones "genitals under circumstances that in fact are likely to cause affront or alarm."

In response to this incident at the coffee shop, citizens at a town meeting on June 8 will consider an ordinance proposal that would regulate where, when and how "sexually oriented businesses" may operate in town. The ordinance would prevent such establishments from being near residences, schools, day-care centers and places of worship, and would

not permit the business to serve alcohol, among other conditions.

Even though the existing permit wouldn't be affected, the shop owner says the ordinance proposal is a direct attack on his business and threatens to sue the town if the ordinance is approved by voters. He now has said he plans to apply for a new town permit to expand the shop's seating capacity and hours of operation and acquire a license for a strip club.

## Musings On Finding Other Naturists

# Privacy Guidelines For Children

The author suggests a critical, but difficult task for parents is to teach children, "...the importance of personal privacy at home and the concept of proper and improper behavior related to privacy." After all, kids being kids just might want to be with mom and dad, even when they are in the bathroom or bedroom. Even more astounding, they might even want to take a bath or shower with them. Nipping this in the bud is crucial to their education in proper ideas about privacy and modesty. Do you agree with this author's position? If so, or if not, why?

Summary of the instructions given by the author:

1. When dressing in the morning, instruct your children to get out of whatever room you will be dressing in. Make them aware that your body is private and that it is totally improper for them to see you undressed. This is doubly so for an opposite sex child. Further, they should dress alone as well.
2. When bathing, tell the kids that you prefer to be along to bathe. "Tell them that you would be embarrassed if they were to see you without clothing." This plants the idea in your child's mind that there is the need for modesty and privacy at certain times.
3. It is recommended that parents be present when children four and under bathe for safety reasons. But, be prepared to give them a wash cloth or hand to cover their lower body so that you cannot see them if they do not want you to look. If they do mind, "...you will know that your lessons on modesty and personal privacy are being taken seriously."
4. For toilet training, "...explain to your children that it is OK for dads and brothers, or moms and sisters, to go to the restroom together as their bodies are alike for the most part."
5. Do not let your children walk around the house in underwear or nude in front of other family members or their friends. If it happens, inform them this is not acceptable and they should cover up in pajamas or a robe.
6. Starting as toddlers teach them about 'good and bad touching.' Make sure they understand that keeping the trunk and pelvic areas of their body covered exhibits modesty, but also "...using personal privacy will help keep them safe."
7. Inform teens that you expect them to act with decorum and modesty in front all family members. The same rules applies in front of peers of the opposite sex for their own safety and because that is proper behavior.
8. Teach your children to make sure that their room blinds are closed when not dressed. "Explain to them that this part of modesty and privacy and something they need to do to be safe."
9. Tell teen siblings of the same sex that it is OK if they choose not to dress in front of each other. They can take turns dressing if they share a bedroom or one could dress or undress in the bathroom with the other dressing or undressing in the bedroom.
10. Parents, be consistent, do not walk around the house undressed as your children might see you.

11. Parents, always lock the bathroom door behind you to prevent anyone coming in without permission. This goes for daughters as well. This will save everyone and prevent "...having to answer questions that any younger children could pose and that they are not yet ready to be confronted with."

Final tips

By following these guidelines you are teaching your children modesty and personal privacy. Importantly, "... you are helping them remain safe as well as preparing them to behave in a proper manner in their private lives."

This is essential as sexual predators and pedophiles are always looking for children of all ages to victimize. Inform your children that even if they close the door to their room, or the bathroom blinds and curtains, they still should not stand in front of the windows to undress or dress. Their shadow could possibly be seen by someone walking or driving by outside, thus endangering their safety.

The word that comes to mind after reading these guidelines for teaching privacy and modesty for children is: disturbing. What is this writer thinking? The author purports to be an expert in child development. However, no sources are given to allow the reader to know what theoretical or empirical basis there is for these recommendations.

Naturalists don't quarrel with the need to teach about good and bad touch and not being nude in front of open windows. Beyond that, the word 'bizarre' comes to mind for the other suggestions. It is sad to think anyone holds such extreme views about the body within the context of the family.

The writer asserts that there is a need to instruct children that total privacy is needed for the nude body. The exception is for same gender parent and child and sib. However, this seems to only be allowable while children are very young and needing assistance with bathing or toilet training.

The author approves of children under age four developing a desire to cover their genitals even with their parent. This is a sign that the lessons in privacy and modesty are having their desired impact on young minds. Of course, the author seems totally oblivious to the potential negative effects of these recommendations once a child internalizes them.

The word modesty is bandied about by the writer as though its meaning is obvious. Of course, the writer's implication is that it means keeping the body covered. Anything less is immodest. While not spelled out, the implication is that this is improper and probably by extension also immoral.

The writer in suggestion two states that a parent being seen naked by their child would cause embarrassment. This is a very loaded word as it implies shame. Thus, the thrust of the writer is to advise inculcating body shame in children as a powerful motivation to stay dressed and to fear nudity.

Next the writer, in recommendations six through eleven links the absolute demands for forbidding nudity to safety concerns. It is asserted that by being dressed they will be "safe."

The final tip warns of pedophiles that apparently are everywhere looking for children to molest. Somehow, if they keep the blinds drawn and no one ever sees them nude, they are safe from the danger of sexual predators. This is a highly dubious association.

Possibly the author of these recommendations has never heard of gymnophobia. However, what she suggests would likely increase the likely hood that children would develop this disorder. Below is a description of what gymnophobia does to a person.

“...but those suffering from the phobia can explain that it rises from a feeling of physical inadequacy.

The fear also stems from a certain incident where the victim was disclosed in front of the others that must have sparked a feeling of awkwardness in the mind. This leaves a persistent mark of stress and anxiety, which burgeon into phobia in the later stage.

It is not unnatural that you may be intensely anxious of sexuality and be reluctant to get into intimate situation with anyone.

Gymnophobics are sensitive about circumstances where they fear about negligible things like taking a shower in the bathroom or changing clothes in front of people. You will possibly live in a morbid fear throughout your life, unless you have the will power to overcome it.

This type of phobia is basically caused by the unconscious mind as the protective mechanism. The present situation is always linked to some past event at some point in your life when you must have confronted an event linking to emotional trauma and nudity.

Remember that, the original catalyst is a real-life scare and the fear haunts the rest of life. Some kind of movies and TV programs may also trigger this kind of situation. But at the end of it all, the phobia does not erupt abruptly but with reasons from the past.”

Would any reasonable parent want to foster this sort of phobic reaction in their children in the name of modesty and safety? Learning societal standards for dress and reasonable safety precautions do not require these draconian measures. Children are a lot smarter than people give them credit for. [Ed.]
