# Another Perspective On Stephen Gough

Last month's Bare Facts gave an update on what has been happening to Stephen Gough. It was suggested that his jail ordeal has gone on long enough, and it would be in his best interests to declare victory and get out of Scotland to carry on his protest in friendlier territory. However, as the saying goes, there's more than one way to skin a cat, (no offense to cat's intended). Here, Tom Pine offers his thoughts on Stephen Gough in this month's online publication, *The Naked Truth* and offers a strategy worth considering. [Ed.]

What about Stephen Gough? Here's a man, who served his country in the military, and by the way, simply wants to walk naked the length of his native Scotland, wearing nothing more than a hat, boots and a backpack. Time after time he's been arrested and time after time the court has turned itself inside out to trump up enough of an offense to imprison the man. The charge they're using these days is "a breach of the peace." Why is that?

Quite frankly it's because the courts can't make the nudity charges stick. Vincent Bethell has proved that point by going nude in the middle of London and won his case in court. Mr. Gough has served months in jail, (amounting to over a year in solitary confinement!) and has undergone psychiatric examination over what he has called a "right to personal freedom."

Whose peace is he breaching here, that of the police? On his earlier walks, he even informally talked with elementary students about why he walked naked, while the teachers monitored the meeting. Imagine that! Why are the police stubbornly pressing a case without the concomitant complaints, (in any quantity) from the public? It bears consideration.

Let's think about the greater implications of this. The Scottish authorities have spent upwards of £200,000 prosecuting this case. They've held a man in prison, in solitary confinement, for the heinous crime of simply showing the society around him what a human being looks like without clothing. A "breach of the peace" indeed!

Are you beginning to see what's going on here? The law is, to put it bluntly, *harassing* Steven Gough.

In my view, they have far exceeded their jurisdiction. Here is a blurb from a recent article: Journalist and supporter Bob Janes said: "This seems like it will carry on and on. Both sides are too intransigent but the law is bigger than he is. He has still got a fairly loyal band of supporters, but a lot of people think he has gone too far. I am a naturist myself but I am not doing jail time for it."

Basically, Scotland is throwing its weight around against a citizen on the most tenuous of charges. This may seem incomprehensible to Americans, who have that marvelous Constitution, Bill of Rights, and the presumption of innocence going for them, but under Scottish law you are guilty until proven innocent.

The last part of the statement is significant to me: "I am a

naturist myself but I am not doing jail time for it." Before you agree with that, let me posit this scenario. What do you suppose the Scottish police would do if naturists showed up outside the prison, two-hundred strong, and stripped off in support of Gough? Can you imagine the scene in booking, with the police trying to process that many people? Then, what if they did that *every single time* the police arrested Gough. How long do you think it would be before the intransigent police wilted and realized the wrongness of what they are doing? Would they be bigger than *that*?

It seems to me, and I don't write this flippantly, Gough is suffering from a lack of support from naturists, as well as the greater society. Why aren't his supporters and followers protesting constantly outside the prison at this breach of human rights? Why aren't they using the weight of the media (a powerful force indeed) to bring their case before the world? For that matter, why aren't the Scottish *taxpayers* objecting to the misuse of their *taxes* for a non-crime? After all, £200,000 isn't exactly lunch money. Why aren't people yelling, "I'm mad as hell and I'm not going to take it anymore!"

Over the centuries, authorities from Rome on down have punished Christians over their faith, up to and including, ostracizing them, imprisoning them, or even killing them! Christians endured it because they believed in their faith. On a lower level, Steve Gough does what he's doing because he *believes in his right simply to exist as a naked person.*

I think he deserves all the support we in the naturist community can give him, however large or small a gesture. It would be interesting to see a naturist group organize a worldwide "Naked Stephen Gough" day, akin to the "World Naked Bike Ride" day. Think of it, groups all over the world, standing in front of prisons naked, holding up placards that say, "Support Stephen Gough! Support your right as a free person to go naked!"

The whole issue comes down to this simple fact: do we as individuals *own our own bodies*? If we don't, then the state has every right to dictate what we can or cannot do with it. If we do, then we have the right to display that body *any way we see fit.*

People dress in many different ways, sometimes modestly, sometimes provocatively. People wear jewelry and employ body modification techniques. People wear tattoos and style their hair outlandishly. All of the above takes place without arrests. Why then, is it beyond the pale to display my body without clothing? It's not like societies haven't ever done it before.

We, as naturists, need to start standing up for our right to exist as a naked person, so long as we don't violate common sense and decency. There is nothing indecent about a naked human body, per se. Nearly seven billion bodies exist all over the planet. Think of it as far more than a recreational choice. Think of it as a *fundamental human right.* That's the way Steven Gough sees it. I think we should see it that way too.

## Spencer Tunick

Love him or hate him, Spencer Tunick knows how to draw a crowd these days. In the great long ago, he had to beg people in twos and threes to pose for his publically staged nude photographs. Not so anymore. The throngs of “fifteen minutes of famers” can’t wait to shed their clothes for the sake of art.

He is quoted as saying, "I'll never get a chance to do this again, it's not worth being inhibited," Rush said. "It doesn't feel sexual, it just feels tribal, a gathering of humanity." There it is – that’s the theme we need to latch onto and make it synonymous with naturism!

Thanks to Tunick and the fig leaf of “ART,” thousands of people got to do something they secretly in their heart of hearts have always wanted to do – go naked in public! What a revelation! Despite the millennia of brain washing about the necessity of clothing, there still beats within the human breast the desire to be free of all encumbrances and just be human!

## Sunny Spain

Looking for an exotic naturist vacation destination? We all have heard of Mexico, the Caribbean, not to mention Florida. How about Spain? Come to think of it, don’t forget Portugal either – but that’s another story.

Never gave Spain a thought? It may sound too good to be true – but it is. Naturism is protected by the Spanish constitution. I wish the founders would have thought of that here. Read on. [Ed.]

Naturism is winning followers throughout the world. Some people see it as a way of life, some people think of it as an aberration and yet others see it as a great business. In any case, it seems that this phenomenon does not stop spreading. Despite this, naturism is still seeking its place in a society that seems increasingly tolerant.

Countries like Germany have a long naturism tradition. In the case of Spain, it is a more recent phenomenon. Only two decades have passed since the crime of public scandal was abolished, a law inherited from the Franco regime that could be applied in case someone offended “decency or morality with scandal or acts of grave importance.” But years have passed and nudism has been implemented gradually. For example, in Barcelona, there is a long list of naturist beaches. Today the law protects Spanish nudity on the beaches and the city itself is a nudist town. One can go without clothes in the street if they so wish.

## What’s A “Tonopah”

Good question, wrong pronoun, but more about that later. "Tonopah" means "Hot Water Under The Bush" in the Native American Hohokam language. Water used to flow out of the ground at several locations in town before the white invaders began pumping it on a large scale.

They just have seemed to be good people. I have for years read the thoroughly interesting adventures these two have had exploring the U.S. for hot springs and skinny dipping holes. The readers of ‘N’ will no doubt recall their names and delightfully written adventures. I might add that Bill Pennington is a frequent contributor to the Rixplace online opinion and discussion website devoted to all things naturism. Shall we just say Bill is forthright, and leave it at that?

If you check your handy HOT SPRINGS AND HOT POOLS

OF THE SOUTHWEST, BAJA, & HAWAII guide you will find detailed information for finding El Dorado Hot Springs in beautiful downtown Tonopah.

Since the publication of this well written and illustrated guide, the hot spring has new owners. However, the previous owners Camilla Van Sickle and Bill Pennington, who built the hot spring up from nothing but a piece of desert dirt, kept 1.2 acres, the labyrinth, two houses and one hot spring when they sold the place. They now call their little section of desert, Casa Blanca Hot Spring. This is very convenient since we specifically wanted to meet Camilla and Bill.

After contacting them via e-mail, a day was scheduled for our visit. About those 40 miles on I-10 – you can't say the desert is featureless, but you can say it's the same features over and over and over again.

Unless you call five buildings a town, to dignify Tonopah as a town is a bit of hyperbole. Ok – three gas stations, a restaurant, post office, real estate office, thrift store and plant nursery. Despite this, I couldn't find Casa Blanca Hot Spring on the first try. In my defense, it's not marked, except for the address – 41301 Indian School Road. Local folks gave me directions. It's next door – as in, "You can't miss it." We didn't either! It helped that there was only one other entrance, and nothing on the other side of the road. Oh well, when without GPS, follow your nose!

I will specify this. Casa Blanca Hot spring isn't your typical commercial operation. Scratch the word commercial and say, donations welcome. It's a business model we understand well, if not with fondness. One more thing, it's not a resort, it's – rustic! We know that model as well.

I am reminded of the cable TV network that describes its self as, "Characters welcome." That's the charm of Casa Blanca Hot Spring.

We pulled in and weren't sure where to go to check in. We didn't really have to bother. There's no real check in. We found Camilla busily working on the ceiling of their front porch and introduced ourselves. Somehow, Bill hadn't mentioned to her that we were coming, but she informed us that he would be back shortly. Camilla then graciously showed us the 1.2 acres of land they now have before pointing us to the stand alone hot tub filled from their hot water well.

Just as we were headed to the tub, Bill showed up and offered us a copy of the aforementioned hot springs guide for half price – a deal we couldn't refuse. Then before joining us for a soak, Bill chided me again for treating him as something of a naturist celebrity. I then explained that my desire to meet Camilla and him was not so much that they are celebrities, but that I genuinely appreciated all their travels and trip reports promoting good old skinny dipping and nude use of hot springs.

Bill's outspoken genuineness and unassuming enthusiasm for nude living is infectious. Standing free of clothing, arms stretched wide, he loudly proclaimed his pleasure at being in

the naked state. His is a bold, "Heck yes I like to be nude! It's the way God made us! There ain't nothing to see, that we don't all have!" Bill isn't so sure there is a God, but he does approve of the Bible depiction of God creating humans nude and saying that it's all good! We are right there with you on that Bill.

A few minutes later Betty Prange joined us, taking a break from painting the interior of her motor home. Betty is another of those "characters welcome" people. She's been touring in her various motor homes for the last 17 years, ever since her husband went to that Big Hot Spring In The Sky. She became an avid naturist with Camilla and Bill nearly ten years ago. We heard the short version of her life story and travels; that she's a photographer; that she drives a tour bus in Yellow-

stone every summer; and that she is having one of the men also camping out at Camilla and Bill's work on the electrical problem she is having.

Returning to the tub after a break, we were joined by a couple who had recently experienced a fire that destroyed their mobile home. They hadn't been naturists, but are renting a small house on the grounds of Casa Blanca Hot Spring until they can decide what to do. Suffice it to say, the wife joined us nude in the tub to tell their story.

A little later a gentleman recently caught up in the bad economy had lost his job and decided to buy a used motor home. Somehow, he too ended up in Arizona sitting nude in a hot tub, telling his story. Maybe that's what hot tubs are for.

All too soon it was time for us to head back to Phoenix, but not before saying goodbye to Camilla and getting a tour of their unique home. Wouldn't you know it? There's another story here.

This small white stucco house Camilla and Bill now call home wasn't built on this spot. Nope! It has traveled through time to be a fix-r-upper at Casa Blanca Hot Spring. It originally was built in 1924 in Phoenix, but for some reason was off loaded in 1950 and left for ten years half way to Tonopah. Later, someone moved it to the present location. How a little white stucco house endured all that, I don't know. But, Camilla and Bill are loving it back to life. And now we know why it's called Casa Blanca Hot Spring.

So if you happen to be driving along I-10 on your way to some other place, call Camilla and Bill (623-203-2230) to see if there's space available at Casa Blanca Hot Spring. Relax awhile in the hot tub, and share stories with other travelers on the road of life. There's tent and RV camping, hookups, dump stations, a retreat cabin, and sometimes there are rooms for rent. Remember, characters welcome! [Ed.]

# Bad News From Florida

An incident earlier this year during the TNS Mid Winter Festival at Sunsport Gardens in Florida sparked a number of exchanges on the Rixplace internet naturist forum. What appears here is a sample of three of many exchanges discussing the ramifications of the incident.

As a participant in an outing to a local beach to photograph a nude peace symbol, George Winlock describes the events that took place at Delray Beach which led to police and Child Protective Services being called to investigate both public nudity and possible child abuse.

This then stimulated lively debate about the actual incident and about the status of naturism in our society as the two other submissions demonstrate. Let's face it naturism is still viewed as a fringe activity, merely tolerated by some and found abhorrent to many. Navigating our way through the morass of official and unofficial ignorance and hostility is no easy task.

Naturists seek to neutralize or deflect public suspicion, pushing past accepted limits in order to break out of a ghetto mentality. Yet, to do so entails calculated risks that have to be taken. Judgments about risk are not always wisely made and some backfire. Fortunately, after the fireworks died down, this was not the case in this instance.

These issues are complex as these writers indicate. Follow their debate to gain a sense of the uphill battle naturists are fighting. [Ed.]

As I understand it Morley has had a number of people from Child Protective Services visit him at Sunsport. Because the law requires that complaints to CPS must be investigated they are frequent visitors even though in past visits they have seen the children well nourished, not really bruised, and quite happily playing.

CPS did an investigation while I was there for the Midwinter Festival. I did not see them personally, but heard from reliable sources that they were there.

Fourteen of us, (including our photographer) had a field trip to Delray Beach to do the nude peace symbol. We stripped and got into our positions on the beach, had our pictures taken, and then were told by the police that we were to remain on the beach until they got our name, address, and other information. We were told that we were in violation of a local ordinance against nudity and were also nude in front of a child.

The child was part of our group and both his parents were with him. Naturally because there was a child CPS was notified and a visit to Sunsport was required. Each person in authority had to cover his a\*\* and pass things up the line. I actually found the whole thing funny, (others in our group did not) and got even more of a laugh as I was walking off the beach and one of the officers thanked me for coming.

My experience is that not all people want to be educated.

I have been at this for some 35 years now and despite best efforts the press still has us prancing, strutting, and cavorting in the nude, and we are still relegated to nudist "colonies." One has to consider why, after a generation, there have been no improvements.

We as naturists are sometimes progressive thinkers and expect that society will apply reason and logic. Sadly, that is not the case. People drive through stop signs every day, and people still insist on driving across railroad tracks even when the gates are down and the lights flashing....

I grant you this is a somewhat cynical view of society on my part but it never ceases to amaze me that the public does not want to be confused or influenced by the facts, and would rather hang on to whatever they deem to serve their personal beliefs, even when the facts point otherwise.

The debate over child welfare people visiting Sunsport Gardens is just such a story.

As reasonable thinkers we see there was no problem, the authorities found no problem, and in fact there is no problem.

However, closed-minded people who insist on believing different, despite the blatant facts otherwise are going to keep pressing the issue. It is that segment of society that we need to remain diligent about and be concerned

about. We do not have to agree, but like a lit match next to a can of gasoline, we want to make sure that we keep a watchful eye that they don't get too close to each other.

Consider how long it took the human race to conclude that the earth was round and the resistance to that very scientifically proven fact.

The human race has not changed in its preference to grasp at their superstitions. All that has changed is the arguments on the table.

We expect that our laws will protect us, but the fact is that people with an agenda non-compatible with ours often influence the system.

We claim to be a country of equal rights codified in law, but almost no week goes by that the press doesn't have some kind of story showing some kind of discrimination.

The Scopes "Monkey Trial" may have brought Darwin to the forefront, but the law that caused that trial was never removed from the books and remains there as a symbol of a state's defiance.... DMK

To me these issues are, (to repeat a point) complex whether you're trying to do only one thing or ... more than one.

To be philosophical about it, I would say that most controversial issues around these days are complex. That's sort of why they are controversial... People tend to form their opinions before they've really examined all the details. That's understandable too – life is short. *Ars longa, vita brevis*....

Personally, I have little patience for people who tend to see things as black & white, friend vs. enemy, "for us" vs.

“against us,” etc. – or just plain “simple,” when in fact, reality is complex.

I could list a lot of examples from politics, but that would just start irrelevant debates. Naturism/nudism itself furnishes plenty of examples. There are the silly arguments over naturism vs. nudism, TNS vs. AANR, whether a person without clothing is “naked” or “nude.” In fact, there’s plenty of fuzziness in all these dichotomies. As the saying goes, there are just two kinds of people: those who see dichotomies everywhere and those who don’t.

“Non-sexual” vs. “sexual” nudity is another poor distinction. There is not only a lot of gray between the extremes, but it’s not even a one dimensional thing. Sexuality itself is multidimensional. The full range of human thought and behavior in most areas is very multidimensional.

It’s precisely the insistence on oversimplification that makes nudity and nudism so hard for most people to get their minds around. It’s just so much easier for most people to think of nudity as always sexual, (and outside of a narrow range of “acceptable” circumstances) automatically “sinful” or “pornographic.” Out-of-the-ordinary nudity is just for “weirdo’s” and “perverts” or, at the very least, “eccentric.”

It’s understandable that politicians and public officials like to express themselves in black vs. white terms. Saves so

much time when one must explain one’s position in a 10-second sound bite, for an audience that doesn’t really want to hear the details anyhow.

Personally, I rather prefer complexity. It leaves room for surprise, novelty, creativity, and escape from the boredom of the “same old, same old.” That’s one of the attractions of naturism/nudism to people who aren’t daunted by complexity – it adds new dimensions to social interactions. Many, (most?) people just find that threatening.... CD
