Naked Hiker Charges Dropped

Interesting things are going on up North. The outcome of a case involving a nude hiker appears to create a precedent distinguishing between simple, nudist nudity and lewd, sexually oriented nudity. If so, this is a significant plus for nudists. Such a distinction in law clarifies that public sexual behavior is not allowed, not simply being nude. This makes sense and, from the nudist perspective, squares with reality. We can only hope "reality" will spread to the south. [Ed.]

The law has tried to stop the 60 year old free-hiker, Brian Coldin, who frequents a local recreational trail from walking naked. But it failed. Instead, charges were dropped which may set a precedent for nudists.

Two off-duty police officers witnessed Mr. Coldin walking naked on the Uthhoff Trail in Severn Township in September 2009.

At the Coldin trial in Bradford, Dr. Ronald Langevin testified adults or children who are exposed to nudity do not suffer any psychological harm. While he agreed people who see nudity unexpectedly might experience shock, embarrassment and even be offended, he indicated there was no evidence those people would suffer any permanent psychological harm. He added nudity is generally well accepted in society as evidenced by media, nude beaches, and the gay pride parade. While different people's reaction to nudity would vary greatly given that Canada is a multi-cultural society, Dr. Langevin was adamant that nobody would suffer any psychological harm.

Dr. Ronald Langevin has been studying sexual offenders and their victims for over 40 years. In preparation for this trial, he reviewed 195 scholarly studies as well as his own personal database of over 3,000 offenders. Dr. Langevin put special emphasis on a 1995 study by Dr. Paul Okami at the University of California, Los Angeles. The study concluded that children who are exposed to nudity do not suffer any harm.

Dr. Langevin was also very specific that nudism/naturism is not exhibitionism. Sexual arousal is key to exhibitionism as a sexual disorder. The scholarly research he reviewed clearly indicated nudists/nudists are not motivated by sexuality. In fact, Dr. Langevin recalled he dealt with two genital exhibitionists who had tried nudism/naturism but did not like it. He added even in cases of simple genital exhibitionism there was no evidence of psychological harm to the victims.

Mr. Coldin was charged with several counts of nudity in the Bracebridge area. Mr. Coldin readily admitted to regularly walking in the parkland adjoining his property while wearing only sandals. His lawyer, Clayton Ruby, has planned a constitutional challenge to section 174 which criminalizes mere nudity – (Section 173 deals with indecent acts).

The Federation of Canadian Naturists supports the decriminalization of mere nudity. It is ridiculous the simple exposure of our natural body (such as being nude in your backyard or seen through your house's window) could result in a criminal charge. Casual nudity should not be in the same league as theft, robbery, assault and murder.

It is important to note indecent acts are covered under a separate section of the criminal code. As such, there would still be ample room to charge exhibitionists and other sexual deviants.

At this point, the concern is this case may not challenge the constitutionality of the law because Mr. Coldin may be found not to have been nude on a technicality. The law does not define nudity and merely wearing shoes and/or a hat could be enough for the court to find that he was not nude.

The defendant's lawyer believes the decision sets an important precedent. "It is a landmark case in the sense that the law

has been applied to nudists and naturists. Now there is a clear pronouncement that a naturist is not engaging in an indecent act.”

The man was initially also charged with nudity in a public place, but that was withdrawn in September of this year.

Stephane Deschenes, director of the Federation of Canadian Naturists, says naturists are just embracing their “natural self” and shouldn’t have to fear being out in the public. He added, “We, as a society, have a real phobia about our own body. We are so incredibly uncomfortable that we find our own image embarrassing, shameful and offensive.”

The Crown did not receive consent from the Attorney General to commence proceedings, which is required on a nudity charge. The indecent act charge was dismissed because what the man was doing was not harmful, that is, not engaging in a sexual act. Acts that would constitute this charge are public masturbation, luring for sexual act, luring children and flashers, he noted.

This is an important trial because it has the potential to change the law on nudity. If the court decides nudity is not harmful, it could make section 174 of the criminal code (nude in public) invalid because, with no harm, there is no reason to put such a restriction on personal freedom of self-expression.

The first three court dates were held on September 27, 28 and 29, 2010. A final court appearance is set for 1-25-11.

City Turns Deaf Ear To Nude Beach

The city of Delray Beach, Florida is in the news due to the request by David Armstrong, speaking on behalf of area nudists for an official nude beach.

This group has been lobbying for a clothing optional beach for the last six years.

Armstrong notes that those who like to swim nude pay taxes and deserve a portion of beach set aside for clothing optional use. He claims it would bring millions in revenue to Delray Beach, possibly as much as \$100 million dollars a year based on a study of the economic impact of Haulover Beach near Miami.

The vice mayor scoffed at the projected millions in revenue that would come to the area and dismissed any intention of changing city ordinances to accommodate a clothing optional beach. His rationale is such a beach wouldn’t fit with the child-friendly and family-friendly principles found in Delray Beach.

Armstrong has gathered 45,000 signatures from residents, visitors and local business owners and plans to attend a January 25th meeting with city officials to continue his lobbying efforts.

Stripping In The Amazon

It may be better to be underdressed than overdressed when hunting with the Awa, one of the Amazon’s last nomadic people, according to a BBC reporter visiting a remote tribal area in Brazil. The reporter and film crew were on hand to accompany local Awa tribesmen on a hunt in the jungle. The Awa are a tribal group that was only contacted by the outside world twelve years ago.

The reporter, dressed in typical western garb of hiking boots, jeans and shirt discovered he really wasn’t appropriately dressed for the hot, humid jungle conditions. Even a short walk was enough to work up a heavy sweat. Entering the village, he realized just how overdressed he was.

The purpose of the news story was to show how the global demand for Brazil’s resources, in particular from China, is driving deforestation. In the short period of time of contact the virgin forest has fallen to the loggers and the land is the most degraded of any indigenous tribe in the Amazon.

Walking into the village it became abundantly clear some hunting traditions remain strong. The Awa hunters were completely naked except for a piece of string decorated with bright bird feathers tied to the end of their penises.

They looked at me in my sweaty shirt and jeans and laughed. One motioned towards my groin and gestured as if he were tying a knot. The others laughed even harder. Clearly, they thought I should dress more appropriately.

“I am not wearing one of those and that’s the end of it,” I said. I turned, perhaps a trifle petulantly, and stomped off into the forest behind one of the hunters.

Returning from the hunt everyone was drenched in sweat. We came upon a river that runs through the Awa territory and the hunters indicated that they were about to take a dip.

Checking to see the coast was clear, the reporter stripped off and dived in too. “The Awa seemed delighted that at last I was surrendering to the spirit of the hunt.”

Noticing one of the young hunters on the bank brandishing a piece of string, the reporter guessed what was coming next and eventually gave in to the prank and was “dressed” in traditional Awa hunting garb. All to be recorded by the film crew who suddenly appeared.

How Nudism Can Save You Money

Nudists (or “naturists” as some prefer to be referred to), have been the brunt of many a joke for many years. However, the truth of the matter is that living a nudist lifestyle may actually be far better for you, physically, ecologically and economically.

That dirty word – “**Laundry**”: Let’s start with the obvious. Nudists tend to wear as little clothing as possible, usually nothing at all, as often as possible or whenever conditions allow. Most live in climates that are tropical enough to maximize this opportunity. Wearing less clothing means washing less clothing, and washing the clothing that they own less frequently, requiring the repair and replacement of clothing less often.

They also tend to have less of a wardrobe, requiring less storage space. So here, we are seeing a saving in money spent on laundry detergents, gas and electricity to operate a washer and dryer, replacement clothing and repair costs, home closet or storage space. We also see less chlorine, phosphates, ozone and carbon dioxide pumped into the environment as well as a reduction in health issues related to exposure to the chemicals needed for properly washing clothing. (Chlorine bleach is one of the deadliest chemicals we can expose ourselves to).

Cooling Down: Since for practicality reasons, most nudists live in either tropical or subtropical regions, many homes and businesses in those regions have some form of air conditioning. Nudists can save money and as in the case of laundry, the environment, by being able to turn up the thermostat a few degrees and allowing the natural cooling system provided in our bodies to do its job. Also, if things get a little too hot, it is very easy to simply jump in a cool shower or hose off for a second or two without having to take the time to get undressed and redressed. Besides, who wants to throw those sweaty clothes back on right after a shower?

Health Costs: There are other bonuses as well. It has recently been found that exposure to natural sunlight is far healthier to the human body than attempting to hide from the sun altogether. Regulated exposure to natural sunlight lets the body naturally produce all of the Vitamin “D” it needs to ward off a host of deadly and debilitating diseases, cancers and conditions, including MS, ALS, osteoporosis, breast, ovarian, prostate and brain cancers. Even more recent reports indicate that almost all sunscreens are completely ineffective in reducing the deadliest forms of cancer, melanoma. Several reports indicate that the ingredients used to manufacture sunscreens are actually more harmful than the cancers they purport to prevent. However, by balancing the ratio of Omega 3 and 6 fatty acids, combined with an adequate amount of Vitamin “D,” incidence of melanoma has shown to be reduced by around 40%. It is therefore better to gradually expose the body to the sun, slowly building up our body’s own natural sunscreen, melanin, being careful not to get sunburned in the process.

The bottom line is that nudists can save a ton of money by not buying sunscreen, simply exposing themselves to natural

sunlight in appropriate amounts; thereby creating Vitamin “D” for free and by simply eating a diet that balances omega 3 acids. This can be done through supplement or through adding fish, flax or kiwi fruit to their diets. The real savings come from not having to pay medical bills for treatments for all of the conditions.

Stuff: Nudism is often referred to as the “Great Equalizer.” When people are naked around other people, it is difficult to tell if a person is the president of a bank, or a school janitor. Consequently, nudists tend to be far less “class-conscious.” Nudists are typically less likely to want to keep up with the Joneses, realizing that not only do clothes not really make the man, but neither do homes, cars, boats, etc.

More Health - Less Stress - More Money: Studies have also found that children raised in nudist homes tend to be more socially developed (and often more intelligent), than those raised in “textile” families. Nudists generally feel that they have nothing to hide. That attitude permeates the rest of their psyche as well, so they tend to be less stressed out and more sure of themselves. We have probably all heard about the health problems produced by living under stress. Nudists save money by not having to treat as many stress related disorders. Also, by being more self-confident, and supposedly better educated, they are more likely to get better jobs, making more money.

Society: Those same group of studies indicated that children raised in nudist homes are less inclined to become burdens to society. They are less likely to become involved in early sexual or drug experimentation or to commit crimes against society. This is partially because they are not as materially oriented and because they are already familiar with the looks and workings of the opposite sex. In general, nudity allows them to be more open and honest in their family life, which is expressed in how they relate to others in general. Nudists save money by not having to bail their children out of jail, take them to the doctors to treat sexually transmitted diseases or help them raise unwanted grandchildren (as frequently). If all families raised their children with the same attitudes as nudists, we would all be able to save money by having to pay less in taxes to support fewer children of unwanted pregnancies, drug addicts, juvenile delinquents, vandalism, etc.

Nathan makes some good points, but I wonder who among us lives even close to this ideal? The ideal is grand in theory, but most of us live our real lives with our naturism being just one of many things we do. Oh sure, social nudity and body acceptance is a lot of fun for a weekend at Lake Edun or some nude beach, but who among us seriously take it as a true way of life?

While not trying to suggest that naturism is an all or nothing proposition, after all, most of us have to live and work in the textile world. Despite this, do we try to consciously modify our practices by incorporating nudist values where practical in our everyday lives? Just a thought. [Ed.]
